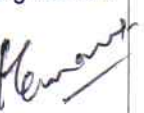

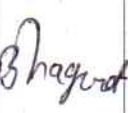

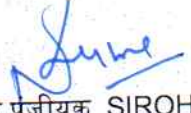

PART-1**PREAMBLE, AIMS & OBJECTIVES OF THE TRUST****1.0 PREAMBLE**

The **SETTLOR** hereby establishes a **Public Charitable Trust (N.G.O)** – with the **SPIRIT of World-Peace: universal brotherhood: non-violence: patriotism: national integration: democracy, socialism and secularism**, without any discrimination of cast, creed, creed color, sex, race, community or religion for welfare of the world, for the purpose of the **Aims**.

OBJECTIVES OF THE TRUST, UPON WHICH, THE CONDITIONS ARE SET FORTH HEREUNDER.

1.1 NAME OF THE REGISTERED TRUST (NGO)

That the **TRUST/NGO**, is named in the remembrance of the *Sage, Anopdas Ji Maharaj* and will be known, as under.

4.0 **OBJECTIVES (National Welfare Issues)**

At National Level, the Trust would undertake to pursue, with Central as well as State Government, on its own and/or in association or affiliation with reputed Non-Govt. organizations (NGOs) and the other Charitable Trusts, having similar purposes, for fulfillment of its AIM& Objectives, as under.

4.1 **To enable- ECONOMIC FAIRNESS & SOCIAL JUSTICE**

- a) **Protection of Human Rights & Dignity of the Poor People**
- b) **Democratic Rights & Accountable Government**
- c) **Fight against Corruption, Hoarding, Black-marketeering Laundering**
- d) **Economic Fairness & Social Justice for Common People, particularly the Dalit's, SC, ST, BPL, Other Backward Classes & the Downtrodden**

- e) Freedom of Expression to propagate the Trust's Aims & Objectives
- f) Free education Opportunities & Health Facilities for the Have-Nots
- g) Food Security, Housing, Employment for Urban & Rural Poor

4.2 OBJECTIVES (Local Welfare Issues)

4.2.1 To Construct **JHUPADIS** of *Shri Anopdasji Maharaj* in the as many villages/towns as possible and distribute free of charges, the Book "**JAGATHITKARANI**" for spreading the message of Earth-safety and welfare of the general public, by organizing Meetings / Gatherings, **Seminars and Annual Conference (Melas)** etc.

4.2.2 To convey *Saint Soni Harichandji Maharaj's* sermons/preaching, written in his sacred *Granth* **Atam-Puran Nyay-Chintamani, Aadu-Puran-Bhajnavali, Naklang Patra**, to common people for their awareness towards dedication to the public service to awaken the Bhaviks (followers) of Anop Mandal International, for their Character Building, Complacence and bodily Incarnation, through **Bhakti-Yoga/Dhyan-Yoga**", reciting of *Bhajans* regularly for developing the feeling of brotherhood and harmonious relations among the Bhaviks.

4.2.3 To establish close coordination and solidarity with the all of **Shri Anopdasji Maharaj, Trusts, Seva Samitis** and other organizations – affiliated to the above named trust – situated in the country at various places, villages, Cities and towns, to convince them to adopt the main AIMS & OBJECTIVES of this Trust and to follow its policy decisions declared from time to time.

4.2.4 To provide necessary financial aid to different **Jhupadis** and other charitable organizations which are actively engaged in helping and habilitation of the poor, very needy and helpless members (Bhaviks) of the **Anop Mandal International**.



4.2.5 To organize medical camps at least once in a year, at some of the important places or towns, where *Anopdasji Maharaj's Jhupadis* are situated such as: Free Eye Operation Camps, including free Distribution of Spectates, Blood Donation Camps, Free Health Checkup Camps, generally for the people of BPL category.

4.2.6 To provide every possible help to the dedicated *Bhaviks*, from the TRUST Funds, in the event of their emergency, any unfortunate incidents, accidents or in case of death of any *Bhaviks* or their family members and share their feeling of sorrow by attending condolence meetings, so as to promote and develop a sense of brotherhood, unity and solidarity with this TRUST.

4.2.7 To protect Environment, stop felling of trees and encourage plantation of as many trees as possible.



4.2.8 To help increase literacy and to every effort for education of the boys and girls.

4.2.9 To inculcate both, Hindus and Muslims to self-impose ban on cow-slaughter and request the state as well as the central government to pass necessary legislation in this regard.

4.2.10 To provide necessary monetary help and/or physical services. (by deputing the TRUST volunteers) to the affected people, in their event of earth-quake, famine, excess raining, flood, thunderstorm, tsunami, arson, epidemic and other calamities. To promote non-violence, sympathy towards all the living creatures, encouraging vegetarianism and to rescue all the people from the habits of all kinds of intoxication and addiction.

4.2.11 To support and help establish birds' nests and cow-houses, their maintenance and upkeep for habitation of birds and animals.

PART – II

BYE-LAWS OF THE TRUST

1.0 MEMBERSHIP

The TRUST shall have following categoriesOf members. Any person who is adult and has faith in the AIMS and OBJECTIVES of this trust, can seek membership of the trust, by making an application, in the prescribed form. The board of trustees alone shall be competent to approve or disapprove, accept or reject any membership application of any individual without assigning any reason.

1.1 FOUNDER MEMBERS

That this trust has bestowed the title of "Nakalng Avtar" upon *Shri Anopdasji Maharaj*, the founding father of "ANOP MANDAL" and accepted him as the "paramount head" or "MAHA MANYA PRAMUKH" of this TRUST. And as such, the first trustees appointed by the settlor on the board of trustees and who contribute minimum Rs. 5100/- Rupees five thousand one hundred only) each towards the corpus, of the trust, shall be the first trustee or founder members of the TRUST, after the TRUST is duly registered as a public charitable trust (NGO), by the district sub- register, under the Registration Act, 1908

1.2 GENERAL MEMBERS OR BHAVIKS

Any eligible person, whose name has been approved by the board of trustees, on an application by him/her, would become general Member or **BHAVIK** of the TRUST, on making a minimum contribution of **Rs. 501/- (rupees five hundred & one only)**.

2.0 THE BOARD OF TRUSTEES

2.1 The trust will be managed by a board of trustees consisting of not less than 3 trustees and not more than 11 trustees, the parties of the **SECOND PART** will be first trustees and they shall automatically form the board of trustees.

- 2.2 Upon due registration of the trust, the SETTLOR will be the ***President & Chief Managing Trustees*** of The Trust/NGO and he will hold the office for his life time. However, after his demise or in the event of his relinquishment of the office of *The Chief Managing Trustee*, his legal heirs, successors, executors, administrators or assigns etc, will be appointed as The President & Chief Managing Trustee, as per Trust Board Resolution.
- 2.3 The term of office of the first trustee shall be for this respective lifetime. The board of trustees shall have the power to increase the total number of trustees up to the maximum number as stated above and fix their term as a provisions contained herein.
- 2.4 As stated above, the registered office of this TRUST, which is being established in the premises of *Shri Anopdasji ki Jhupdi* with its existing infrastructure (on the survey no. 1182/2; 1215/1; 1186/1; 1187/1; 1186/1.), Sirohi, shall be operational under the trust board, with immediate effect from the date of its registration.
- 2.5 That the management of entire affairs of this trust, with its registered office at above mentioned address, will automatically come under administrative control of *The Chief Managing Trustee* with immediate effect from the date of its registration/amendment and henceforth, the whole staff including the *Poojari*, looking after the day-to day activates of *Shri Anopdasji ki Jhupdi*, Sirohi, will be required to report to the *Chief Managing Trustee* for all practical purpose like: cash collection from the "*Daan Peti*" (money box), including donation money received separately from the *Bhaviks* and other public; room rent or guest charges received from different persons staying in the rooms of the *Jhupadi* premises and submission of up to date accounts to *The Chief Managing Trustee*.

2.6 That *The Board of Trustees* will be empowered to review the performance of the *Poojari* and other staff engaged for the routine services like –(a) performing daily Pooja, (b) Maintenance and upkeep of the jhupadi properties, (c) arrangement of facilities for meetings, Bhajan Sangat, (d) Lodging Arrangement for BHAVIKS coming for attending such meetings etc. and their stay in the rooms or rooms or premises of the Jhupadi complex (e) timely payment electricity water bills etc. and that if and when their performance round to be unsatisfactory and in contravention to the Trust's interests, then the same staff, including the *Poojari* will be removed/replaced forthwith.

2.7 Rights of admission into the trust's office premises – i.e. *Shri Anopdasji Maharaj ki Jhupadi, Sirohi*, will be reserved from date of the trust's registration and no person, be it a student or any persons, other than the registered members of BHAVIKS, will be allowed to enter or stay in chief managing trustee, who will have powers, to disallow such persons or seek written permission from the board of trustees. The decision of the chief chief managing trustee, on behalf of the board or trustees, will be final and binding on such persons concerned.



3.0 TERMINATION OF MEMBERSHIP

3.1 The board of trustees shall have powers to terminate a trustee or member (Bhavik) from the trust on following grounds:

- i) **On death**
- ii) **On submission of resignation letter**
- iii) **If found to be involved in any anti-social activities**
- iv) **If adjudged by any court of law to be a criminal offender**
- v) **If found guilty of violating the aims and objectives of the TRUST**
- vi) **If he or she has not attended three consecutive meetings without any reasons or written permission of the board**

vii) If he/she disregards rules and regulations of trust or disobeys the decisions of the board of trustees.

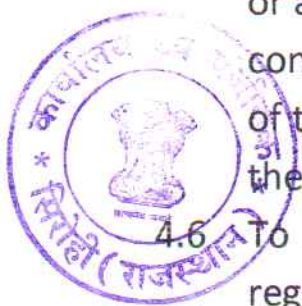
- 3.2 Any trustee any retire from the membership thereof by giving two calendar months' notice in writing of his or her intention to do so, to the board of trustees and after the expiry of the period of notice, the member giving such notice shall ipso facto cease to be a trustee or member of these presents.
- 3.3 Any vacancy caused by death or resignation of any of the trustees, of any board of trustees.
- 3.4 The trustees who are not the first trustees shall hold office for a period of minimum 3 years from their date of appointment by the board of trustees. At the end of this 3rd year, the board of trustees may reappoint them for subsequent term or appoint other persons as trustees in such a manner that the total number of trustees does not exceed the approved maximum number of trustees.
- 3.5 The Chief Managing Trustee shall have the power to remove a Trustee, including any of the first trustee, as per above rules or if he is accused of misappropriation or misuse trust funds or property, and after satisfying himself on enquiry, such action shall be final.
- 3.6 The proceedings of the board of trustees shall not in any way be invalidated due to any posts remaining vacant. When a vacancy is not filled up, the remaining trustees shall act as "full board", subject to the presence of quorum in the meetings. Any vacancy in the board of trustees or illegality in the appointment of trustees or their proceedings shall not invalidate any prior decision of the board.

4.0 TRUST ADMINISTRATION & POWERS TO THE BOARD

The board of trustees shall be empowered as under, subject to the laws in force from time to time.

- 4.1 To administer the trust and affairs and do all the things which will fulfill the performance of the **aims and objectives of the trust**, for which the TRUST is established and for this purpose, the board can apply the whole or any part of the trust property towards the payment the expense of the trust.
- 4.2 The income and properties of the trust will be solely utilized towards, the objects of the trust and no portion of it will be utilized for payment to the settler, trustees or their relatives by way of salary allowances, profit, interest, dividend etc.
- 4.3 To open bank accounts and operate the same by any two members of them authorized on their behalf.
- 4.4 To invest trust funds in the manner not prohibited by any provisions of the income tax act, 1961 as per trust act.
- 4.5 To buy, sell, mortgage, grant, lease, hire of otherwise alienate all or any of the properties of the trust in its description for adequate consideration, so any sale or alienation of immovable properties of the trust can be done only after obtaining the prior approval of the *Income Tax Commissioner*.
- 4.6 To make or modify the objectives and schemes, rules and regulations of the TRUST for carrying out objectives of the TRUST for of affairs thereof and/or running the trust activities.
- 4.7 To appoint Advisory Committee and other such committees and sub-committees comprising of the trustees and/or other persons, the board thinks necessary for the furtherance of the trust's objectives.
- 4.8 The board may, from time to time, associate with any person or persons of public eminence and may appoint or make provision for appointment of any person as chairman of any project undertaken by the trust or chairperson of any committee constituted by the trust for the purposes of administration of such projects or schemes.

- 4.9 The board may employ or engage on contract or appoint as consultant etc. any person or persons to render services on such remuneration and terms to be determined by the board of trustees and persons so appointed shall be accountable to the *Board of Trustees*.
- 4.10 To execute power of powers of attorney to any person for the purpose of executing, administering or managing the whole or any part of the trust for the purpose of all or same among the objects of the trust.
- 4.11 To borrow money with or without security and to repay the same.
- 4.12 To receive, collect and enforce recovery of all monies due payable to the trust and grant receipts and discharge therefore.
- 4.13 To settle, compromise or compound any disputes or refer the same to arbitration or litigation.
- 4.14 To receive voluntary contributions from any person or persons from India or outside, after complying with the statutory formalities, by way of donation, gifts or in any other manner and to hold the same upon trust for the objects set forth herein.
- 4.15 To appoint, suspend, dismiss or otherwise deal with the staff required for the administration of the trust, to frame rules relating to their salaries and other benefits and generally to exercise all powers ancillary and incidental to effectively carry out the objects of the trust.
- 4.16 The board shall have power to make and rescind rules and regulations for the management and administration of the trust.
- 4.17 No trustee shall commit any act or breach of trust of the trust fund or property or cause any loss to the trust property or commit fraud in the administration of the trust fund/property.
- 4.18 The trustees shall hold honorary office and shall not be entitled to any salary, allowances or perquisites, except for the

reimbursement of actual expense incurred in connection with attending to the trust matters in India or abroad.

4.19 The board of trustees will follow the instructions given by any donor who makes substantial contribution towards furtherance of the objects of the trust, so long as such instruction are not detrimental to the attainment of the objects of the trust and are in conformity with the provisions of the income-tax act, 1961.

4.20 For the management and administration of the trust, the board of trustees shall appoint following office bearers.

- 1) President & chief managing trustee
- 2) National convener
- 3) General Secretary
- 4) Finance secretary
- 5) Media In-charge & spokesperson
- 6) In-charge, public relations
- 7) Zonal head and general members of the zone.

Whose terms of office from their date of appointment shall be for a period of 3 years or more and shall be under the administrative supervision of the chief managing trustee and will report to him directly.



5.0 DUTIES & RESPONSIBILITIES OF ABOVE POSTS

The powers, duties and responsibilities of all the office-bearers are defined below. In addition to these, the chief managing trustees may grant additional roles, responsibilities and powers to any of the trustees.

5.1 PRESIDENT & CHIEF MANAGING TRUSTEE

In addition to discharging normal duties of the TRUST, *The Chief Managing Trustee* shall function as the *PRESIDENT* of the TRUST to establish close coordination and relations with the concerned Govt. agencies; Similar National Trusts, as well as renowned NGOs, to organize / attend meetings, conferences, seminars of the trust at national level and visit foreign countries on invitation

to attend meetings/conference organized by the international NGOs and/or UN bodies, such as ESOCOS, for the purpose of pursuing the Trust's Aims and Objectives.

The President & Chief Managing Trustee will preside over meeting of the board of trustees. He will be authorized to sign all documents, including bank documents, acknowledgements for the contributions received, and agreements with individuals, government institutions and other organizations, on behalf of the board or trustees, he shall have all the residuary powers, not explicitly assigned to any of the other officers in these presents.

The President & Chief Managing Trustee is authorized to sign along with the treasurer bank cheques, deposit release vouchers etc. In case of any trustee's activities are found to be not congenial to the activities of the trust, then the *Chief Managing Trustee* will be empowered to remove such trustee from the TRUST and its offices forthwith. The *President & Chief Managing Trustee* will be responsible for ensuring that the trust pursues its aims & objectives and for maintaining the dignity of the trust organization and shall use his influence the government as well as other organization, to promote the same.



5.2 NATIONAL CONVERNER

The **National Convener** will be responsible for organizing various meetings/seminars/presentations and coordination with the trust's various zonal head offices, including holding additional charge of a particular zonal head office, (till the date of regular appointment from the particular zone), liaison with the state as well as central government departments concerned and other trusts/NGOs. As far as the matter of submitting any memorandum to the district collector or staging of and/or calling off any peaceful demonstrations or agitation or hunger strike or "Sit-in Dharna"- for some limited or indefinite period – (To draw central or state governments attention towards any burning issues of

public interests) – is concerned, he will be authorized to take appropriate decision in consultation with or on approval of with the board of trustees. **He will, however, function in consultation with the president & chief managing trustee and in his absence, he shall have the functional power and authority, delegated and assigned to him by the chief managing trustees, for pursuance or trust's Aims & objectives.**

5.3 GENERAL SECRETARY

The general secretary shall maintain the records of the organization prepare and circulate agenda and minutes of board of trustee meeting for the approval of the President & Chief Managing Trustee.

The General Secretary shall be a so responsible for the day to day Trust activities. The secretary shall deal with correspondence received by the trust send replies in consultation with the President & Chief Managing Trustee and Finance Secretary where necessary. He will be responsible for the safe custody of all the properties and records of the trust. He shall represent the trust in all legal matters, sign the papers related to legal cases, attend to courts or represent the trust in government offices.

5.4 FINACE SECRETARY

The finance secretary will prepare annual budget, monthly and yearly expenditure statements get the expenditure audited by auditor duly appointed by the board of trustees and place them before the board of trustees for approval. He is responsible to maintain cash book and prepare vouchers for the payments made, receive contributions, sign acknowledgements for the amounts or articles received by the trust and prepare monthly and yearly statements of revenue and expenditure, as well as, the register of assets of the trust and place them before the board of trustees for their approval. The finance secretary is authorized to

cheques, application for drafts and payment instruction jointly with the *President & Chief Managing Trustee* and draw money from the bank, up to the limits defined by the board of trustees in their meetings. The treasurer is responsible for safe custody of cash, bonds, securities etc. of the TRUST.

5.5 MEDIA IN-CHARGE & SPOKESPERSON

The media in-charge and spokesperson will be responsible for issuing press notes, printing and other publicity of trust's grants, books, pamphlets, banners, posters and other publicity materials of the trust. He will be authorized to arrange press council, answering media queries and giving policy statements on behalf of the trust.

5.6 IN-CHARGE, PUBLIC RELATIONS

The public relations in-charge will be responsible for establish close contacts and cordial relations with the general public, organizing lectures on the *Aims & Objectives* of the TRUST. The Board of Trustees will constitute a national council to promote the affairs of the TRUST on such terms and for such tenure as may be decided by the board of trustees. Such council will be called the "**RASHTRYA PARISHAD**" whose tenure will be for a period of 3 years or as decided by the board of trustees.

6.2 The "**RASHTRIYA PARISHAD**" or **NATIONAL COUNCIL**. Constituted under the advice and guidance of the board of trustees, will be initially represented by the nominees (minimum 2 & maximum 5 each) from all the places where *Shri Anopdasji Maharaj's Jhupadis* are situated and from the villages or areas where a considerable number of *Bhaviks* are staying and thereafter a period of 3 or more years, as decided by the board of trustees, such representatives will be elected democratically from their respective areas.

- 6.3 The "**RASHTRITYA PARISHAD**" or **NATIONAL COUNCIL** will be governed by **SABHA PATI** or **Chairman**, along with **UP-SABHPATI** or **Deputy Chairman** and assisted by a **Secretary**; **Joint Secretary** and a **Treasurer**. All these posts will be appointed by the **Board of Trustees**, in consultation with zonal heads of the trust.
- 6.4 The members of "**RASHTRIYA PARISHAD**" or National council shall work on collective basis and be answerable to the board of **TRUSTEES**.
- 6.5 The meeting of Rashtriya parishad or National council will be called at least once in 3 months or as per decision of the board of trustees.

7.0 **NAKLANG MAHA SABHA (NAKALANG GENERAL ASSEMBLY)**

The "Nakalang Maha sabha" or Nakalang general assembly, will be constituted by the general members or registered bhaviks living all over the country. The "Nakalang maha Sabha" will be governed by the "Sabhapati" or speaker, along with "Up-sabhapati" or deputy speaker and assisted by a secretary; joint secretary and a treasurer. All these posts will be appointed by the board of trustees, in consultation with the regional heads of the trust. Its tenure will be for period of 4 years or as decided by the board of trustees. The meetings of Nakalang Maha Sabha or Nakalang sabha or Nakalang general assembly, will be called at least twice in a year or as decision of the board of trustees.

8.0 **MEETINGS OF THE BOARD OF TRUSTEES**

- 8.1 At least once in every calendar month or more often, if required.
- 8.2 Meeting of the board of trustees shall be convened by the managing trustee and he shall preside over the meetings. In his absence, the managing trustee may authorize the national convener to be the chairman of such meetings. In the event the managing trustee or NATIONAL CONVENER are not able to attend the meeting may elect one amongst them to be the chairman of the meeting.

- 8.3 One half of the board of trustees or a minimum of three trustees, whichever is higher, shall constitute the QUORUM for the board of trustee meetings.
- 8.4 All decisions shall be carried out by the majority decision of the board but in the event of equality of votes, the managing trustee presiding over the meeting shall have a casting vote.
- 8.5 Any resolution in writing signed by all the trustees by circulation shall have full force as though it has been passed at a meeting of the board of trustees.
- 8.6 The meeting of the board shall be convened after giving at least a week's notice unless all the trustees agree to accept a shorter notice.
- 8.7 The board of Trustees may invite other persons interested in the objects and functioning of the Trust to attend the meetings of the Board, but they shall not be entitled to vote in the meeting of the Board.

9.0 BANK ACCOUNT

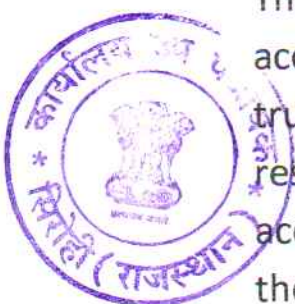
The managing trustee and the treasurer shall jointly operate bank accounts on behalf of the trust. In their absence, any of the trustees may be authorized by the board of trustees. By a resolution to operate the bank accounts. One or more bank accounts may be opened in any bank and or banks in the name of the trust.

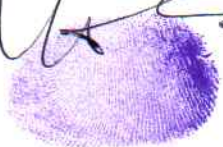
10.0 INVESTMENT OF TRUST FUNDS

The board of trustees shall have the power to invest the funds, assets and properties of the trust at their discretion in accordance with the provisions of the income tax act, 1961.

11.0 ACCOUNTS & AUDIT

- 11.1 The financial year of the trust shall be from 1st Aril to 31st march of the following year, unless otherwise decided by the board of trustees.
- 11.2 The Board of Trustees shall maintain correct accounts of the Trust.
- 11.3 The accounts of the trust shall be an annually audited by a chartered accountant appointed by the board of trustees and the audited statement of account shall be placed before the board for its approval within three months of the close of the financial year.

12.0 AMENDMENTS

- 12.1 While this trust shall be irrevocable, the board of trustees may amend any of the clauses except those relating to objects of the trust, the first managing trustee and first trustee, at a duly convened meeting of the board with at least 2 weeks' notice, and by a resolution passed by at least three-fourths majority of the board of trustees present and voting. The amendments of the trust deed can only be passed by a resolution of the board of trustees in an actual meeting and not by circulation.



- 12.2 If any alternation or amendment is necessary, the same shall be affected through supplementary deed/deeds with the previous approval of the commissioner of income tax and these shall be read together with the main trust deed.

13.0 INDEMNITY

The board of trustees shall be indemnified for any act done by them in good faith in the course of the administration of the trust.

14.0 SETTLOR & HIS RELATIVES

Notwithstanding the powers vested with the trustees under the proceeding clause, no part of the income of the trust shall benefit directly or indirectly the trustees and no part of the income of the property of the trust shall be used or applied directly for the benefit of:

- (a) **SETTLOR**, Chairman & managing trustee, trustees or any Person who makes a substantial contribution to the trust of any relative of the settlor, managing trustee, trustees or the person who makes a substantial contribution.
- (b) Any "**related concern**" in which any of the above persons has substantial interest.
- (c) For the purpose of this clause; the word "**relative**" and the phrases "**related concern**", "**substantial interest**" and "**substantial contribution**" shall have the meanings assigned to them in the Income Tax Act, 1961.

15.0 APPLICABILITY OF TRUST ACT

The provisions of the Indian Registration Act, 1908 shall apply to all matters not specifically mentioned in these presents.

16.0 APPLICATION OF INCOME TAX ACT

All clauses herein are intended to secure exemption from income tax on the income of contributions and donations to the trust and any clause or portion of this deed of trust which is inconsistent with or repugnant to the sections of the Income Tax Act, 1961 as amended, substituted or modified from time to time, shall be deemed to be deleted or modified with effect from the date on which the sections to which the clause or part of a clause is repugnant or inconsistent comes into force.

17.0 THIS TRUST IS DECLARED IRREVOCABLE

18.0 DISSOLUTION

18.1 In the event of dissolution of the TRUST, the immovable property; the "*Jhudadi*" including the office and other buildings In the "*Jhupadi*" complex, shall remain as the *TRUST PROPERTY*, in the legal custody and direct management of the above named *SETTLOR* or After the demise of *SETTLOR*, the Property will be managed by the successor of *SETTLOR*.

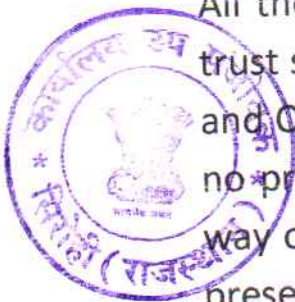

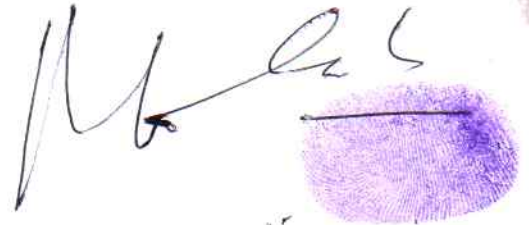
